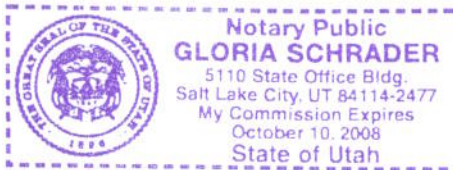
8. Prior to 1976, I observed graders and caterpillars performing maintenance/construction activities on the road.

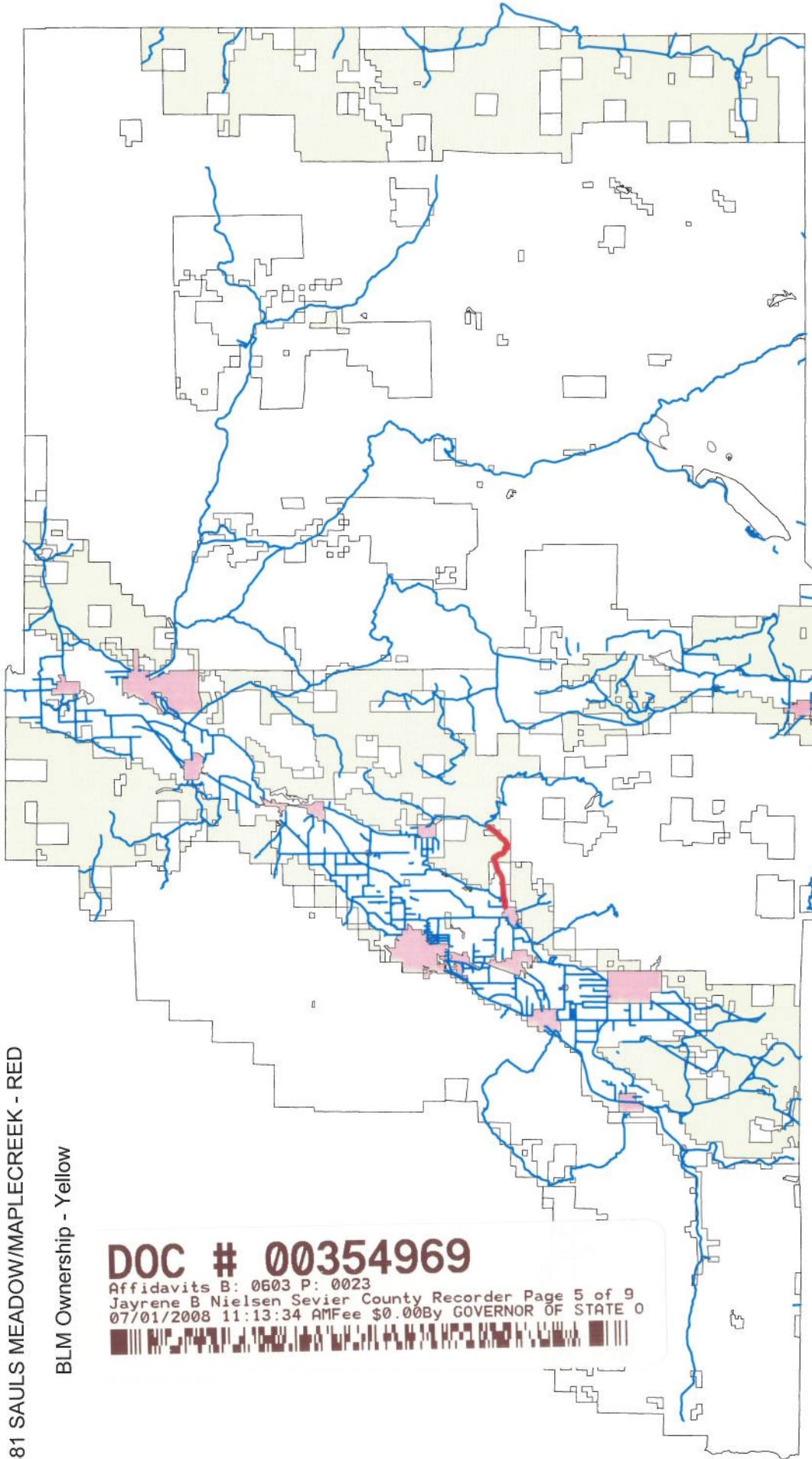

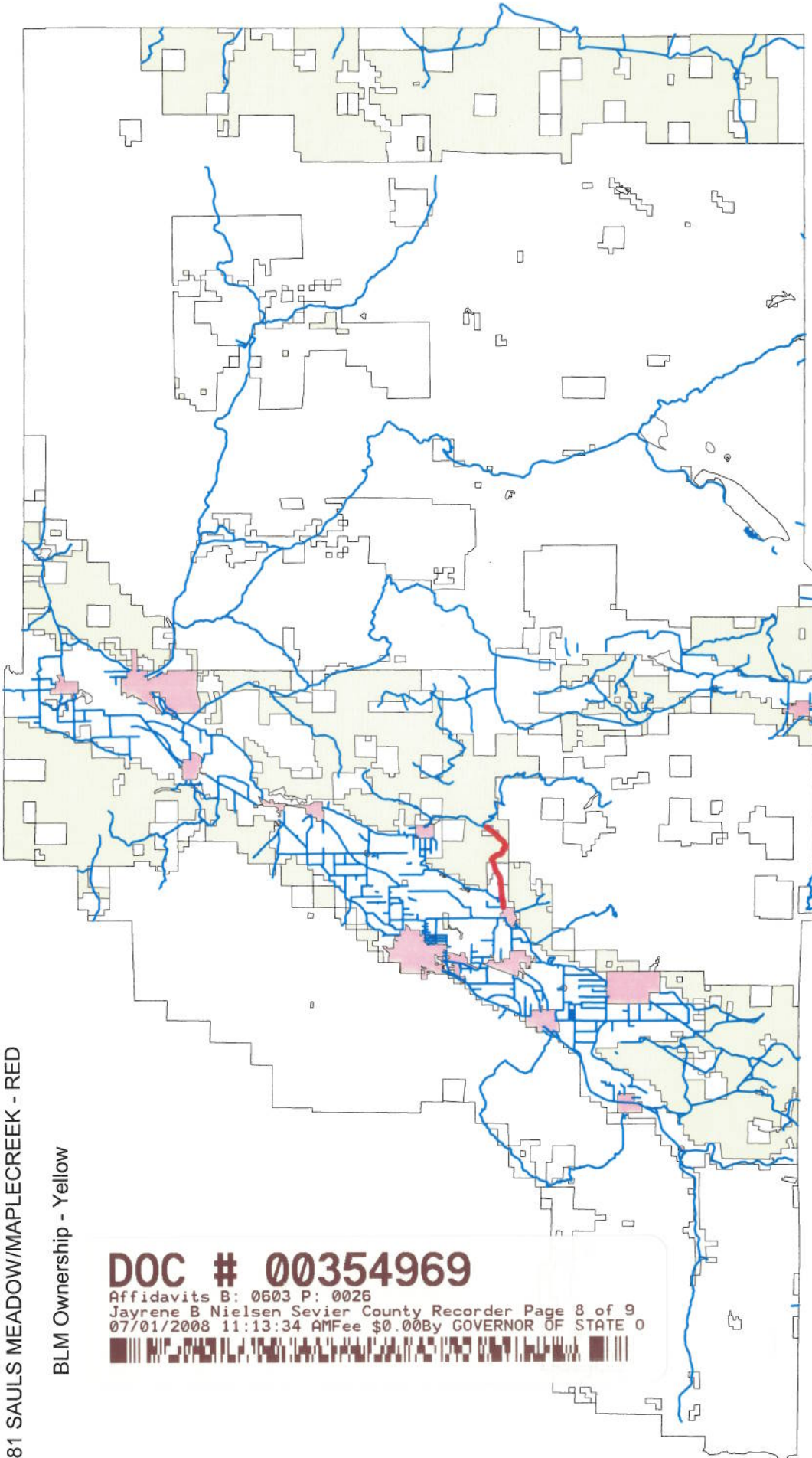
