Section 932 (repealed October 21, 1976, with proviso recognizing the validity of rights-of-way already established)) was accepted for and on behalf of the State of Utah and its political subdivision Uintah County as it pertains to the highway located in Uintah County known as Paradise Park Road; County Road Number: 2020; State Geographic Information Database (SGID) Road Identification Number: RD242225. Total road length is 8.47 miles more or less.

This Amended Acknowledgment and Amended Notice of Acknowledgment supersedes the information contained in the Acknowledgment recorded at Ent 2006012521, Bk 1007, Beg Pg 246.
